Ms Muro presented an update on Bond construction. On the agenda this evening will be an item requesting the Board's approval to purchase the Pioneer Portables. The T-5 classroom was emptied of Cross Fit equipment over spring break. The asbestos abatement has been completed. Signs were put up at the stadium announcing its closure to the pubic beginning April 16th when construction will begin. The first sign of construction will be the closure of the service road. Mr. Howard has been working with the contractor to value engineer the project to reduce some costs and thus far that process is going well.

Maintenance staff worked over spring break to remove all weights, equipment and mirrors in the Weight Room.

The District has received the \$200k award from the City of Lemoore for the CNG project. Mr. Howard will be going out to bid soon for improvements to the CNG facility.

The Foundation held its first Spring Fundraiser this past Saturday. Approximately 140 tickets were sold with approximately 95 in attendance. The Foundation was able to realize a profit through ticket presale, along with four packages that were raffled. Also one of the booster clubs, LHS Athletics, five LHS Clubs

and nine LMCHS Clubs provide packages for the raffle. These groups earned money for their group based on the number of raffle tickets for their package. Ms Muro has received many compliments on the food that was served. The LHS Choir performed and Dr. Solis performed on the saxophone. The Foundation Board has received many very nice compliments from people attending the event and many people expressed a desire to attend next year's event as well. The Foundation felt the event was a great success and would like to make it an annual event.

The Excellence in Education Dinner held last evening was very nice. The candidates were all very accomplished professionals.

The Board members received a copy of the latest District Newsletter this evening. Ms Muro reminded Board members that the KCSBA Dinner is Monday, April 16th, 6 PM at Lakeside School. On April 19th at 5:30 PM LHS will be hosting a Mental Health Forum for the community. Students from Kings County have worked for two years to gather data on Mental Health needs in the area and have produced a very nice video that will be shown along with breakout sessions on available services in the area.
